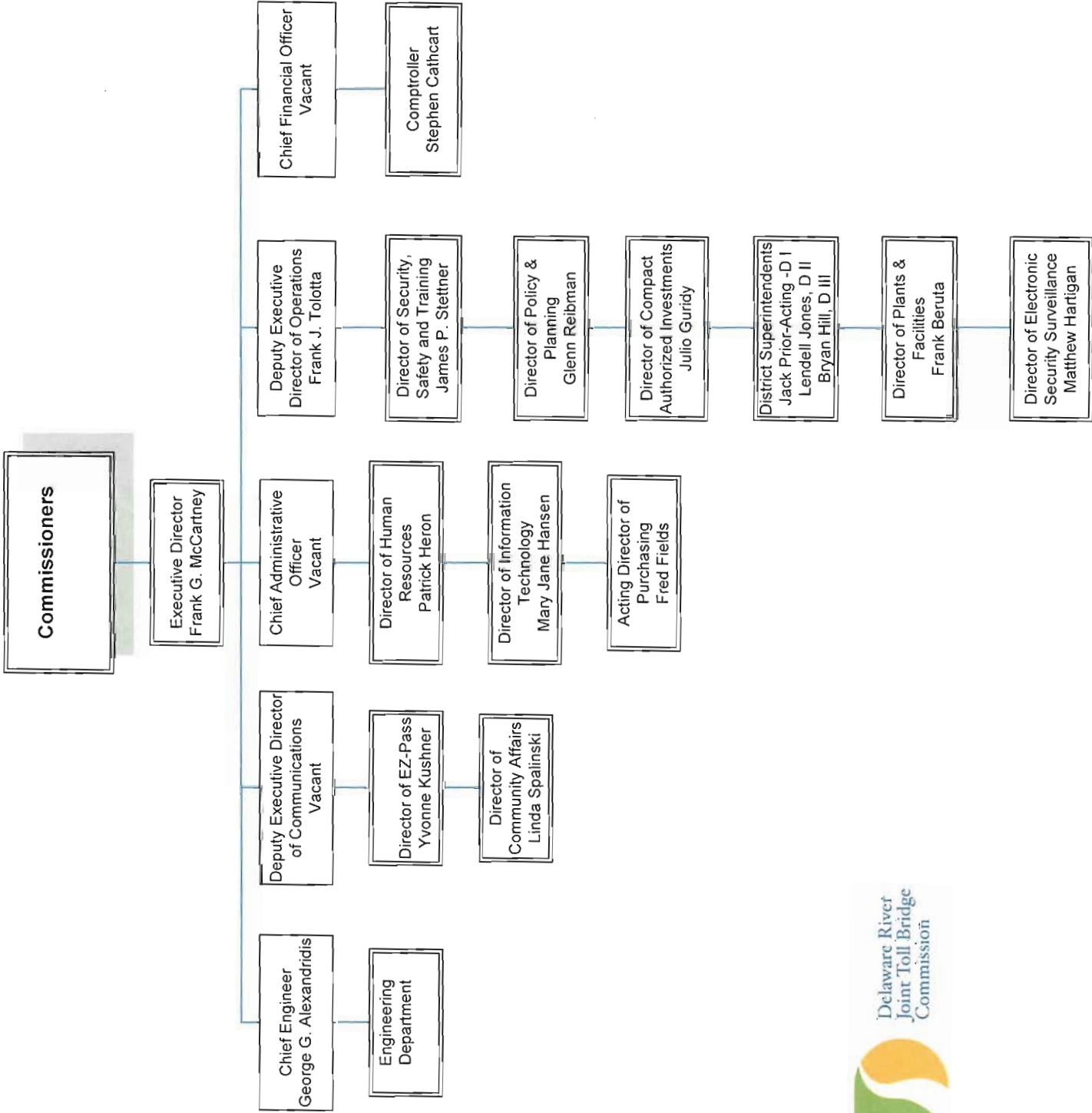

ROLL CALL

Frank G. McCartney, Executive Director, in his capacity as Secretary for this Meeting, called the Roll, and at the conclusion thereof, reported that there was a quorum present--there being five members present from Pennsylvania and five members present from New Jersey.

WELCOMING REMARKS OF CHAIRMAN

Chairman DeGerolamo welcomed those persons whose identities are set forth hereinabove under "Appearances".

INTRODUCE ANY COMMENTS FROM THE PUBLIC

Chairman DeGerolamo addressed the meeting and invited any comments from the Public or Press on items pertaining to today's Agenda.

EXECUTIVE DIRECTOR'S REPORT

Happy holidays to everyone and welcome to the final Commission meeting of 2007. For my year end annual report, I just wanted to provide a quick update on where we stand with some of our capital projects and what to expect in 2008.

As you know, this year we completed the rehabilitation of the Riverton-Belvidere and Centre Bridge-Stockton Toll Supported bridges, bringing the total number of bridges rehabilitated under our capital program to seven. We also have a number of projects underway:

Work on the **Trenton-Morrisville (Route 1) Toll Bridge** is progressing on schedule. This \$100 million project will add an auxiliary lane to the bridge, greatly mitigating safety and congestion issues on the bridge. It will also include rehabilitation, cleaning and repainting of the bridge's

structural steel components, the complete redecking of the bridge, upgrades to lighting and signage and a number of improvements on the bridge approaches.

With the Commission's recent approval of construction and construction management/construction inspection contracts, the more than \$20 million rehabilitation of the **Milford-Montague Toll Bridge** is tentatively scheduled to commence next month, weather permitting. The project includes repainting the bridge and replacing the existing bridge deck, approach roadway pavements and toll plaza.

As you know, the Commission has split its work on **Interstate-78** into two separate projects. The first project, which entails the rehabilitation of 4.75 miles of Interstate 78 in New Jersey, is already underway. This will address cracking of the concrete slabs and settlement of the roadway due to heavy truck traffic along the I-78 corridor and allow for a much smoother ride. The second capital project will include the installation of Open Road Tolling, or highway speed E-ZPass, at the I-78 Toll Bridge. This project, which is tentatively scheduled for completion in 2009, will help to address some of the congestion issues at the bridge.

And the bulk of work on the Commission's **Electronic Surveillance/Detection System** will be completed in the coming year. Initial site surveys are currently taking place and we expect bridge surveys to resume in January. The system will enhance security at Commission bridges and facilities to provide improved safety for Commission staff and the traveling public. Over the course of the next 18 months, video surveillance equipment will be installed at Commission bridges and facilities to provide added security and improve the Commission's capacity to respond to accidents and other incidents at its bridges, buildings, and other structures.

A number of other capital projects will be moving forward in 2008 as well. On the **Scudder Fall (I-95) Toll Supported Bridge**, the Commission will be submitting an Environmental Assessment next year and holding a public hearing on the plans for the bridge. On the **Delaware Water Gap (I-80) Toll Bridge**, we are working with PennDOT and NJDOT to form a task force to address future traffic congestion along the I-80 corridor. In addition, the Commission has engaged the services of a consultant to conduct a structural analysis of the **Calhoun Street Toll Supported Bridge**, the first step in rehabilitating the 113-year-old crossing. We are also in the process of procuring letters of interest for a Phase 1 Rehabilitation and Concept Study for the **Washington Crossing Toll Supported Bridge**.

Clearly, we have a busy but productive year to look forward to as we move ahead with our comprehensive capital program.

NEW HOPE-LAMBERTVILLE TOLL BRIDGE

Effective Friday/today, the Commission has closed the outer (right) lane in each direction of the New Hope-Lambertville (Route 202) Toll Bridge pending the completion of repair work. The Commission does not expect any impact on traffic, as the remaining lanes on the bridge will be adequate to handle projected traffic volumes. The lane closures are projected to be in effect until February 2008, when the repairs are completed.



STATISTICS OF TOLL TRAFFIC AND REVENUE MONTH AND YEAR-TO-DATE PERIOD ENDING NOVEMBER 30, 2007 COMPARED WITH MONTH AND YEAR-TO-DATE PERIOD ENDING NOVEMBER 30, 2006

The following provides a comparison of toll direction traffic volumes for the month and year-to-date periods ending November 30, 2007, as compared with the month and year-to-date periods ending November 30, 2006.

Traffic Volume Comparisons – November 2007 versus November 2006

In the month of November, total vehicular toll traffic for the Commission's seven (7) toll bridges decreased by 63,000 vehicles or 2.0%, as compared to November 2006. Total recorded westbound traffic volume at the 11 vehicular toll supported bridges increased by 44,400 vehicles or 1.8% as compared to the previous year.

In District I, toll traffic at Trenton-Morrisville (TM) for November 2007 decreased by 50,600 cars and decreased by 800 trucks as compared to November 2006, resulting in a 8.4% decrease in total toll traffic. It is noted that roadway construction work for the Trenton – Morrisville Toll Bridge Rehabilitation and One Auxiliary Northbound Lane (T-380B) began in January 2007. At New Hope-Lambertville (NHL), an increase of 2,200 cars combined with a decrease of 200 trucks generated an overall increase in total toll traffic of 1.3% for November 2007 as compared to November 2006. Beginning on November 16, 2007, the outer (right) lanes in each direction of the New Hope – Lambertville Toll Bridge were closed pending the completion of repair work.

In District II, a 100 increase in cars combined with a decrease of 4,500 trucks resulted in a 0.5% decrease in total toll traffic at I-78 for the month of November 2007 as compared to November 2006. The Easton-Phillipsburg (EP) Toll Bridge experienced an increase in traffic volume. An increase of 6,400 passenger vehicles and a decrease of 3,300 trucks generated an overall increase of 0.6% in total toll traffic for November 2007.

In District III, total toll traffic at Portland-Columbia (PC) reflected a decrease of 1.5% for the month of November 2007 as a result of a decrease of 1,600 automobiles and a decrease of less than 100 trucks. At the Delaware Water Gap (DWG) Toll Bridge, a decrease of 13,600 passenger vehicles combined with an increase of 2,800 trucks generated a decrease in total toll traffic for the month of approximately 1.3% as compared to November 2006. Milford-Montague (MM) experienced an increase of approximately 100 passenger vehicles and a decrease of less than 100 trucks, resulting overall in a 0.1% increase in toll traffic for the month.

E-Z Pass Penetration Rates

The following table provides a summary of E-Z Pass penetration rates experienced at the Commission's seven (7) toll bridges during November 2007, November 2006, 2007 year-to-date (YTD), and 2006 year-to-date. E-Z Pass penetration rates for all of the Commission's toll bridges was 57.1% for the month of November 2007 and is 55.9% 2007 year-to-date. Overall E-Z Pass penetration rates increased by 2.3% in November 2007 as compared to November 2006; including an increase of 2.2% in autos and an increase of 2.6% in trucks.

STATISTICAL SUMMARY OF EXPENDITURES

This includes reports entitled “**Budget vs Actual**” covering the month of November 2007 and the eleven month year-to-date operations of fiscal year 2007 relative to Toll Bridges, Toll Supported Bridges and Administration departments.

Total expense plus encumbrance totaled \$3,520,954 for the month of November. For the fiscal year-to-date 2007, total expense plus encumbrances amounted to \$39,523,608 or 96.9% of the year-to-date operating budget. The positive variance between the operating budget and actual expenses is due to normal operating activity.

Several line items are currently running ahead of budget on a year-to-date basis. Unemployment Compensation is currently over its annual budget. Temporary salaries are also running ahead of the annual budget as a result of higher than anticipated charges at the District II toll bridges and Administration. The OT expense for Administration is more than offset by salary savings from vacant positions. EZPass Operating expense is running ahead of budget due to higher than budgeted charges for transaction processing. This line item expense will end the year in excess of its original operating budget.

There were no unusual expenditures or transactions during the month of November.

During the month of November, 2007 the Director of Policy and Planning participated in a number of communications and meetings that explored the following:

The Greater Lehigh Valley Chamber of Commerce Transportation Committee discussed the possibility of doing an advertising campaign to alert the general public to the commonwealth's transportation crisis. The hope is that the general public will then contact their elected state officials to do something more than Act 44.

The Lehigh Valley Economic Development Corporation Transportation Committee discussed the idea of the Lehigh Valley becoming a rail network for Eastern Pennsylvania.

The Delaware Regional Planning Commission's (DVRPC) Planning Coordinating Committee and Regional Transportation Committee heard and viewed a presentation which analyzed the results of the DVRPC's latest traffic counting survey. The survey assesses highway travel trends throughout the Delaware Valley Region by comparing the 2005 traffic volumes with those collected in 1985, 1995, and 2000. Acknowledgement is given to the Delaware River Joint Toll Bridge Commission in helping to make the report feasible by supplying statistics from our Morrisville/Trenton Toll Bridge and the following toll supported bridges: Lower Trenton, Calhoun Street, Scudder Falls, and Washington Crossing.

The Pocono Mountains Chamber of Commerce Economic Development / Transportation Committee discussed Act 44 and the effects of tolling I-80.

The Pike County PennDOT District 4 Winter Readiness Summit included presentations regarding emergency protocols, strategies to combat snow/ice, and other transportation challenges.

The Pike County Road Task Force was given a status update of our Milford-Montague Toll Bridge rehabilitation project.

The Lehigh Valley Transportation Study Technical Committee held a public hearing for its draft Public Participation Plan. PennDOT District 5 gave presentations that included TIP modifications and a major highway status report.

TRENTON-MORRISVILLE (ROUTE 1) TOLL BRIDGE REHABILITATION AND ADDITION OF ONE NB AUXILIARY LANE

DESIGN Contract No. C-380A

The Design Consultant, The Louis Berger Group, continues to provide services through the post-design/construction phase of the project.

CONSTRUCTION MANAGEMENT/CONSTRUCTION INSPECTION Contract No. CM-380B

The Construction Management/Construction Inspection Consultant, Hill International, has been coordinating field activities with the contractor, reviewing contractor schedules, conducting bi-weekly progress and scheduling meetings, preparing daily reports, tracking project submittals and developing public involvement and outreach efforts.

Hill's Public Involvement Consultant, Bergmaier Associates, continues to update the project website, answer customer generated questions via the toll free number and updating the quarterly newsletter.

As a result of the initial OSHA Compliance Inspection that took place in July 2007 one of the recommendations moving forward was for the Commission to perform follow-up safety inspections of the Contract T-380B, Rehabilitation of the Trenton-Morrisville Toll Bridge and One Auxiliary Lane, jobsite.

Hill has hired an experienced Safety Professional (Applegate Associates, Inc.) to perform periodic OSHA Compliance Inspections on the Trenton-Morrisville Toll Bridge Rehabilitation construction site. At the conclusion of each site visit, Applegate will be providing the Commission with a report of their findings. The inspections have taken place in October and November and will be scheduled for December 2007. For the remainder of the project inspections will be scheduled bi-monthly.

CONSTRUCTION Contract No. T-380B

Construction work is progressing on schedule. Stage 1 is underway and expected to last until the spring of 2008. Stage 1 work includes the rebuilding of the toll plaza, construction of the head house that connects the main building to the new toll tunnel, as well as demolition and rebuilding the downstream portions of the main river bridge. Pier cap extensions have been constructed, new structural steel has been set and deck demolition has been completed on the downriver portion of the main river bridge. The contractor is preparing to start the installation of the new bridge deck in these widened locations. New bridge deck has been poured and is curing in a number of spans. The toll plaza demolition has continued with the removal of portions of the existing canopy and toll booths. New toll islands, booths and canopy sections are currently being installed. New structural steel girders are being placed on the widened portion of the PennDOT viaduct over Conrail & Delaware Canal adjacent to Pennsylvania Avenue. Numerous Commission owned overpass structures are also being reconstructed on both sides of the river.

A progress "Partnering Meeting" was held on October 23, 2007 at the Construction Manager's field office. Representatives from the Commission, Berger, Hill and Conti were in attendance. The session was run by a facilitator, FMI Corporation. The next session is scheduled for January 2008.

PRELIMINARY ENGINEERING AND ENVIRONMENTAL DOCUMENTATION FOR I-95/SCUDDER FALLS TOLL SUPPORTED BRIDGE

STUDY Contract No. C-393A

The preliminary Preferred Alternative is the inside widening of I-95 in Pennsylvania, Option 2 at Taylorsville Road and Option 1c – Modified (Roundabout) at Route 29. The Preferred Alternative also includes a total replacement of the Scudder Falls Bridge with the new bridge containing 5 northbound and 4 southbound lanes on an upstream alignment.

A draft technical memorandum on Hydrology and Hydraulic Analysis was recently submitted to the Commission for review. Meetings will be scheduled with state and local agencies to discuss various environmental aspects of the project including the results of the Hydrology and Hydraulic Analysis.

The Environmental Assessment (EA) document is being prepared and a draft will be submitted to the Commission for review in late November. The EA will be submitted to the New Jersey Department of Transportation (NJDOT), the Pennsylvania Department of Transportation (PennDOT) and the Federal Highway Administration (FHWA) for review in early December. The EA will be distributed to the public for review in February and a public hearing is scheduled for March. The final decision document is expected by the end of June 2008.

NORTHERLY CROSSINGS CORRIDOR CONGESTION MITIGATION STUDY

STUDY Contract No. C-395A

The Commission has conducted a series of workshops with NJDOT and PennDOT intended to facilitate establishing a Task Force which will focus on building a consensus with respect to mitigating future traffic congestion along the I-80 corridor in both the eastbound and westbound direction.

A Memorandum of Understanding is currently being developed to include a Problem Statement, Mission Statement as well as Goals and Objectives for the Task Force.

ELECTRONIC SURVEILLANCE / DETECTION SYSTEM

PROGRAM MANAGER Contract No. C-396A

Work includes the continuation of implementation oversight generally focused on coordinating preliminary matters and providing administrative support relating to the issuance of Notice-to-Proceed and the initiation of site surveys.

Jacobs Edwards & Kelcey continues to assist the Commission, together with Counsel, in discussions with Advanced Wireless Services (AWS) license holders who have bought rights to regional wireless frequencies through an FCC auction and determined that their proposed AWS networks will potentially interfere with the Commission's microwave communications system. Negotiations are in progress for an agreement to compensate the Commission for vacating its licenses to operate in the affected frequencies.

DESIGN-BUILD-MAINTAIN PROJECT DB-396A

Mass. Electric Construction Company (MECC) has been actively addressing preliminary matters associated with the start-up of work associated with the Electronic Surveillance / Detection System Design-Build-Maintain Project.

Additionally, MECC has initiated site surveys to document existing electrical infrastructure and existing utilities at each bridge as well as identify potential electrical and electronic surveillance equipment locations and proposed electrical and fiber optic conduit routing.

A Partnering Meeting has been scheduled to be held in mid December for the purpose of encouraging the formation of a cohesive partnership between the Commission, its' Program Manager and the Mass. Electric Construction Company together with its principal subcontractors and suppliers.

NEW HOPE – LAMBERTVILLE TOLL BRIDGE ADMINISTRATION BUILDING RENOVATIONS AND ADDITION

DESIGN Contract No. C-397B

A Request for Qualifications (RFQ) was publicly advertised on July 17, 2007. Seven (7) Contractors submitted their Statement of Qualifications (SOQs) on August 08, 2007. All seven (7) of the Contractors were deemed pre-qualified to bid.

Final construction bid documents were received from VITETTA on September 10, 2007. Construction bid solicitations were issued to all seven (7) firms on September 10, 2007 as construction Contract T-397B. A mandatory Pre-Bid Meeting was held at the New Hope - Lambertville Toll Bridge Administration Building on September 18, 2007. Six (6) out of the seven (7) Pre-Qualified Contractors attended the meeting.

Five (5) Bids were received on October 18, 2007, and bid award was made to Twining Construction Co. Inc. at the Commission November 19th meeting for an amount of \$ 4,529,102.00 via Resolution Number: ENG-01-11-07. Notice of Award was issued on November 20, 2007. Conformed Contract Documents were received from VITETTA on November 20, 2007.

NEW HOPE – LAMBERTVILLE TOLL BRIDGE ADMINISTRATION BUILDING RENOVATIONS AND ADDITION

CONSTRUCTION ADMINISTRATION Contract No. CM-397B

A Request for Letters of Interest (RFLOI) for this project was posted on the Commission's website on November 13, 2007. A non-mandatory Pre-LOI meeting was held on November 20, 2007 with five (5) firms in attendance. Two (2) Letters of Interest were received on November 30, 2007 from Hill International and STV. The results of the Technical Evaluation Committee's (TEC) were presented to the Senior Selection Committee (SSC) for review.

I-78 ROADWAY REHABILITATION CONTRACT

DESIGN

Contract No. C-424A

PB Americas, Incorporated (PB) continues to provide post design support for the project. PB is continuing to respond to Contractor requests-for-information (RFIs), reviewing and responding to shop drawings and other submissions from the contractor and attending the bi-weekly Progress Meetings. PB also held a "Transfer of Knowledge" session on the Drilling and Slurry Grouting portion of the contract with the CM/CI Staff members.

CONSTRUCTION MANAGEMENT/CONSTRUCTION INSPECTION

Contract No. CM-424A

Greenman-Pedersen, Inc (GPI) continues to provide CM/CI services for this contract which includes monitoring and coordinating field activities with the contractor, reviewing contractor schedules, preparation and processing of contractor invoicing, conducting bi-weekly Progress and Scheduling Meetings, preparing daily reports, tracking project submittals along with public information efforts. Also the contractor's Composite Baseline Schedule was approved. The development of the first project newsletter continues as has the responding to customer generated questions obtained via the toll free project hotline phone number, the number which is displayed on site via two variable message boards. A project information card was developed which directs the public to either the Project Hotline phone number or the Commission Website for overall project information and was distributed to the I-78 Toll Plaza, the I-78 PA Welcome Center and the NJ I-78 Weigh Station for further distribution.

CONSTRUCTION

Tilcon New York, Inc. has completed establishing the CM/CI field office. Milling and repaving of the shoulders in advance of shifting traffic onto the shoulders for Stage 1 work was completed as was the videoing and inspecting of the drainage laterals. Work continues on the drainage channel stabilization along County Route 519 under I-78, pipe lining of the drainage laterals, catch basin cover change outs, along with Slurry Grouting in the test area. The composite baseline construction schedule (CPM) has been approved.

STORM SEWER OUTFALL PIPE MAP

Under this Task Order Assignment T&M Associates was tasked with finding, inspecting, and mapping all Commission sewer outfalls in Pennsylvania and New Jersey.

The consultant mapped and inspected all outfalls in Districts 1, 2 and 3 and an internal meeting was held to discuss and finalize the Outfall Inspection Report.

T & M Associates recently obtained additional information with respect to the ownership of various outfalls previously identified as "Commission owned". This new information indicates several outfalls are actually owned by others. The final version of the Outfall Inspection Report and related maps are being finalized to reflect the new information.

PORTLAND BOROUGH SEWER FORCE MAIN CONNECTION LOCATION

DESIGN
Assignment #9

The Borough of Portland has been ordered by the PA DEP to provide a sewage treatment plant to service residential and other facilities within the Borough. The Borough has requested an easement to construct a sewer force main to the treatment plant within Commission property. The Commission and Commission Counsel have been working with the Borough to prepare the requested easement documentation.

The Commission requested T & M Associates prepare a proposal to review the proposed sewer force main plans prepared by the Borough engineering consultant, Brinjac Engineering, and determine the best location for stub connection to which the Commission will ultimately connect our P-C Toll facility. As part of the connection, the Commission is required to install a grinder pump provided by the Borough, and construct a lateral connection from our building to the sewer tap location.

The final report was submitted and comments were provided. The revised final report has been submitted by T & M Associates. It is expected that this Task Order Assignment will be closed by the end of the year.

I-78 OPEN ROAD TOLLING (ORT) LANES DESIGN

DESIGN
Contract No. C-427B

I-78 ORT Lanes Design (Infrastructure Project)

HNTB is continuing with the preliminary design effort and preparing plans and specifications for the preliminary (60% complete) PS&E submission. HNTB submitted the Structural Geotechnical Report and Pavement Design Report to the Commission. HNTB also submitted the Structural Foundation Geotechnical Engineering Report.

The Commission and HNTB met to discuss the draft proposal prepared by DelVal Soil & Environmental Consultants, Inc. This proposal includes effort for the Storm Water Infiltration Evaluation and Testing of the proposed storm water management sites throughout the project limits. The additional work is attributed to Lehigh Valley Planning Commission's completion of an ACT 167 watershed study and changes due to a law suit against DEP that requires more documentation to show there are anti-degradation measures on projects within the Commonwealth, and Williams Township Ordinance specifying additional infiltration and water quality requirements. Prior to moving forward with the approach noted in the draft proposal, Commission staff will request a meeting with the Northampton County Conservation District to determine if this approach is absolutely necessary.

HNTB submitted the draft public participation program. This document is currently under review by Commission staff. It is anticipated that the program will be finalized shortly and HNTB will be requested to implement the program.

HNTB submitted the draft Bridge Deck Evaluation Report. This report summarizes evaluation of the eastbound and westbound Route I-78 bridge decks traversing PA Route 611. This document will be reviewed by Commission staff and finalized by HNTB.

HNTB and the Commission discussed the relocation of an existing center median turn-around area. The turn-around is currently located west of the toll plaza and HNTB was considering relocating it to approximately 400 feet west of the Morgan Hill Road overpass. Upon further discussion with PennDOT Engineering District 5-0, it was determined that a center median turn-around should not be located within an interchange. Therefore, we are now considering not replacing the center median turn-around and will verify that this is acceptable with the District II operation personnel and PennDOT.

The Final Conformed Construction Documents were developed by M&M, delivered to the Commission, and were subsequently reviewed and approved by Commission Counsel in November. The approved Conformed Construction Documents were delivered to both the CM/CI Consultant and the Contractor by the Commission in November. M&M attended a Kick-Off / Transfer of Knowledge Meeting with the Commission and the CM/CI Consultant.

CONSTRUCTION MANAGEMENT/CONSTRUCTION INSPECTION Contract No. CM-430A

At the November 19, 2007 Commission Meeting the Commission ratified the Executive Director's decision, made in consultation with the Chair and Vice Chair of the Commission, to award Construction Management & Construction Inspection Services (CM/CI) for the Milford-Montague Toll Bridge Rehabilitation Contract to STV, Inc. of Douglassville, Pennsylvania. The CM/CI Consultant attended a Kick-Off / Transfer of Knowledge Meeting with the Commission and the Design Consultant in late November and began CM/CI contract services.

NEW HOPE LAMBERTVILLE TOLL SUPPORTED BRIDGE INTERIM INSPECTION AND REPAIR DESIGN

Assignment #4

Subsequent to the GEC inspection of the New Hope - Lambertville Toll Bridge (NHLTB) in August, a letter report was submitted to the Commission outlining the inspection findings. The report noted that ten (10) cantilever floor beam brackets exhibited small cracks in the tie-plate/top flange connections. The report recommended an interim inspection within (3) months.

The purpose of this Task Order Agreement Assignment is to implement the recommendations made by the GEC to inspect and design repairs for the superstructure. This assignment will include an In-Depth Interim Inspection focusing on the cantilever floor beam brackets recommendations for a means of arresting the existing cracks, design and post design services for the crack repairs and recommendations for all necessary floor beam bracket retrofit repairs. The assignment will also include a second Interim Inspection following the repairs.

During the week of November 5, 2007 TranSystems | Lichtenstein performed an interim inspection of the bridge. A meeting was held with the Consultant on November 15, 2007 to discuss the inspection findings. Five (5) additional small cracks were discovered in the cantilever floor beam brackets during the interim inspection. As a precautionary measure, the right lanes in each direction of the bridge, which are partially supported by the cantilever brackets, were closed to traffic on November 16, 2007. Those lanes will remain closed until repairs have been implemented. No adverse traffic impacts are expected from the lane closures due to the light traffic volumes on the bridge. The Consultant is preparing repair plans for the work. This Task Order Assignment will result in bid documents for a construction contract in January 2008 to implement the recommended repairs.

In accordance with Resolution ENG-08-09-07, New Hope - Lambertville Toll Supported Bridge, Pier 2 Priority Repairs – 2007, Contract No. DB-457A was awarded to W.J. Castle P.E. & Associates, P.C. in an amount not-to-exceed \$157,500.

The project includes Design-Build services to be provided by specialty engineer/contractor to perform high priority repairs of the New Hope – Lambertville Toll Supported Bridge. Services include engineering inspection, design, permitting, and construction for the repair of damage to the apron of Pier 2 to avoid possible significant additional deterioration from a future flood event.

Project kick-off meeting and follow-up progress meetings have been held. Underwater inspection work has been completed; design details prepared and repairs are expected to be completed in December.

COMPACT AUTHORIZED INVESTMENT

General

One of the major highlights in the CAI department during the month of November was the completion of the Ferry Street road reconstruction project in the City of Lambertville, NJ. Also, there was a new application submitted from the Township of Ewing, New Jersey and a revised application for the Borough of Belvidere, New Jersey. A very significant meeting was held with 16 major stakeholders of the City of Easton CAI Riverwalk project in an effort to determine the fate of the entire project.

In addition, the CAI department continued its series of meetings with municipalities that need a status update of their projects. These municipalities included: Solebury Township, PA; Montague Township, NJ; and Knowlton Township, NJ.

The CAI department is also in the process of preparing a power point presentation with updates on the CAI projects for the Commissioners' Committee meeting in December 12, 2007.

Update of some of the most significant efforts with the grantees during this month

Pennsylvania

1. Milford Borough, PA – Great progress has been made in the ongoing construction of the CAI project in the Borough. Two DRJTBC – CAI construction signs were erected at both ends of the project and construction is progressing. A ribbon cutting ceremony is being coordinated by the CAI department for January 2008.
2. Smithfield Township, PA – The Project Engineer has submitted preliminary plans to Penn DOT and the Township for review and approval. The County Rail Authority indicated that if utility power will be used under the RR tracks, a PUC permit will be needed. The Township is contemplating using solar power instead of using power lines on both sides of the underpass and off from the RR tracks. A resolution of any engineering comments and issues with Penn DOT and the Township is still pending. The current schedule still remains for the project to go to bid in January and to start construction in April 2008. Bimonthly meetings were set up to review the status updates of the project.
3. Delaware Water Gap, PA –The Borough Engineer is finalizing the project plans and specifications and will be providing a schedule of project advertisement and award in the near future. The Borough is still anticipating construction to begin in the spring of 2008. A status update meeting is scheduled for December 05, 2007.
4. Portland Borough, PA – The Township continues to work with Penn DOT to obtain the HOP permit for the Park and Walk project and to complete the design for a crosswalk and overhead flashing warning light. The Borough has indicated that they have identified an alternate site for the Park & Ride project. Bids are anticipated the first week of December for the Park & Walk project.

5. Lower Mount Bethel, PA – John Mauser, the project manager presented a revised budget and contract from the engineer, with a scope of work, but not an actual contract as required by the Contract Agreement. According to the latest cost estimates, the Township will seek to reduce construction costs by getting donated work from the public work department. The project is now on budget and moving forward. If the municipality stays on schedule the project will be completed by the third quarter of 2008. The project manager is still working on obtaining the necessary permits, especially a permit from DEP. The property deed for the visitor center has not been signed; however, this project and the trail are still in motion. The Township is pending receipt of the DEP permit and the completion of the property transfer documents. The Township anticipates advertising both projects prior to the next scheduled status meeting of December 17, 2007.
6. Williams Township, PA – The Township has received the approved Highway Occupancy Permit (HOP) from Penn DOT and has advertised and received bids for the work. The apparent low bidder is Telco, Inc. at approximately \$288,534.50, which is below the grant amount for the construction phase of \$344,356. The construction of this project should not affect the Commission's upcoming I-78 project.
7. Easton, PA – A meeting was held on November 28th with representatives of the City, the Easton Parking Authority, LANTA, Northampton County, La Fayette Ambassador Bank, and Arcadia to discuss the viability of the Riverwalk project, for which bids were received on October 31st and were well in excess of available funding. In summary, the viability of the project will depends upon whether the construction cost can be reduced through either value engineering reductions or a change to the project, which will be coordinated between the City, the Parking Authority and Arcadia this month. The hearing for the potential injunction requested by the River Keeper group is set for November 30. The CAI due diligence still has the following concerns about the project:
 1. Contract construction schedule for substantial completion is 14 months, and will allow 30-60 days beyond this point for final cleanup/punchlist items to be completed), which extends well beyond the grant agreement date of December 31, 2008.
 2. Currently still need FTA approval for use of funds, and resolution of either additional funding or cost reduction to project.
 3. The CAI is also still waiting for a concept plan to approve before the city can move ahead with the pedestrian/bicycle trail project. The project manager and project supervisor must provide the CAI department with the necessary information before further reimbursement requests can be approved. The City must send a complete request letter to combine the bike path project and the trail projects. The Trolley project is complete for this year and a reimbursement request was submitted by the City, and the City has recently supplied the necessary supporting information to complete processing the reimbursement request for the Trolley project.

8. Riegelsville Borough, PA – A meeting with DCNR Commission permit is pending in order for the project to move ahead for bids. The CAI department received drawings for the pedestrian bridge project. The steps to the towpath have been designed to minimize the impact to both the towpath and the Saxton property. The Borough engineer is completing its E&S plan for submission to the County Conservation District which is expected to be submitted by the first week of November. Upon receiving the approval, the engineer will submit the Joint Permit Application to DEP and concurrently submit our final design drawings to DCNR at that time as well.
9. Solebury Township, PA – A status meeting was held with the project team on November 9th to discuss pending items. Bucks County conservation district approval still needs to be obtained, along with the Penn DOT Highway Occupancy Permit, and DCNR approval of the pre-fabricated pedestrian bridge. The Commission must also formally dedicate the right-of-way along River Road to Penn DOT by completing standard Penn DOT forms, which will be done in December. They think that they can bid the project in January pending receipt of outstanding approvals. The project needs official PICO approval for the park. Bridge and parking lot are in our grant as well as the trail. The organization, Friends of the Canal Park is still against the project.
10. New Hope Borough, PA – A status report from the municipality indicated that the project bids came in over the grant amount. The CAI is asking for copies of the bids to verify the reasons for the excess amount of about 30% of the grant 60K engineering and 190K for the actual construction, but they only used 30K for the engineering so far. We are expecting a letter from the Borough explaining the reasons for the cost increase and formally requesting an increase in the grant amount from the Commission.
11. Falls Township, PA – No significant changes this month. The CAI department is still waiting for reimbursement request from them to close out the project.
12. Upper Makefield Township, PA - The project was advertised by Penn DOT and bids were received on November 8. The low apparent bidder is Road-Con at \$1,987,182, which is within the anticipated budget of the project. The Commission grant is for \$1,447,000 of the total anticipated cost of \$2,247,000, which includes engineering, construction and inspection. The cost of engineering and inspection has not yet been submitted to the Commission and/or finalized. The approval of this project, which is termed by the board of the Township as the Washington Crossing Gateway, has two phases, the DRJTBC is funding part of Phase I. The projects need approval from Penn DOT, PHMC, and the Bucks County Conservation District. The commencement for construction is Mach 2008 with duration thru October 2008. Phase II has not been approved by Penn DOT yet and additional funding for this phase is needed.
13. Lower Makefield, PA –The Traffic signal project is completed and the Township is still getting all the necessary paper work together for a close out. The Township has alluded that it wants to send another project application to the CAI department. The CAI department is waiting for the last reimbursement request. No significant changes have been made since the last report.

14. Bristol Borough, PA – the Borough received its approval on the plans from Penn DOT and received bids on the project on October 26, 2007. The apparent low bidder is Armour & Sons Electric, at \$1,446,049.77, over the available grant amount of \$999,500. The Borough has requested that the Commission consider adding funding to the grant amount, which has not yet been determined.
15. Yardley, PA – The Borough provided a summary of the bids received for the project. The low bidder was Harris Blacktopping at \$504,423.76. The Commission grant will cover \$234,217 of this cost. The project is on schedule and should be completed on time.

New Jersey

- 1 Montague, NJ – Insurance certificate matter required by the Commission agreement was resolved and the contract agreement is in its way to be completed as adequate insurance will be provided to cover the Commission from possible liability. The CAI department is working on obtaining a completed Contract Agreement from the Township and for them to proceed with the project.
- 2 Knowlton, NJ – No quarterly report has yet been received by the CAI department. The CAI Director met with Knowlton who assured him that they will follow up with the requirements of the Agreement. Again, the CAI department encouraged the municipality file an application to complete the trail that they are planning. The CAI department received a letter with copy of deed and property insurance for the property that was purchased to construct a park adjacent to the Portland Columbia pedestrian bridge. A reimbursement request was received and it is being revised as well as the plans for the demolition of the house on Washington Street.
- 3 Belvidere, NJ – A meeting was held on November 27th with the Township engineers who provided a revised application indicating that the Borough was willing to assume jurisdiction over the portion of Water Street from the Commission and the there is no need to remove the concrete from Water Street for the ROW transfer. In addition the idea of relocating the utilities underground was also discarded by the Borough Council. A new cost estimate was presented with application.
- 4 Phillipsburg, NJ –The engineering plans are complete However; the Town is still working on the ROW transfer and the approval of stream encroachment and soil erosion control. The traffic signal study is essentially completed. SHPO gave a verbal approval to the project. The bricks cross walk and utility are still issues that need to be resolved. The Town engineer is ready to go to bids. The engineer will send the CAI department a set of plans. The engineer will have a letter of acceptance for the ROW transfer to be completed for the Town.
- 5 Pohatcong, NJ – On October 15th a meeting with the Pohatcong engineer was held at the Easton Phillipsburg office. The Township is ready to complete its plans, but is waiting for the approval of the Warren County engineer as CR 627 and 627 spur are county roads. The Township is also waiting for the soil erosion permit. The engineer is ready to go for bids in December and to start construction in April. Maintenance & Protection of Traffic Plans will be forwarded to Commission Engineering Department upon receipt by the Township.

- 6 Milford, NJ –Engineer has provided preliminary plan set and is waiting approval of Utility Companies for proposed utility relocations. Meeting on October 28th. Engineer has provided preliminary plan set. Awaiting approval of Utility Companies for proposed utility relocations. An updated cost estimate will be requested as well as whether or not the utility work will be part of the grant construction or a separate contract(s).
- 7 Frenchtown, NJ –Bimonthly meetings will be held with the Borough to monitor the projects progress status. There were not significant changes in November.
- 8 Stockton, NJ – Needs re-authorization of plans from SHPO, anticipating advertisement for bids in January 2008. ROW issue has arisen regarding the ownership of the Bridge St. ROW. DRJTBC Attorney is reviewing this issue. A review meeting will be set up with the grantee. The Ferry St. project is completed.
- 9 Lambertville, NJ –The ribbon cutting ceremony planned for November 19th was cancelled at the request of Mayor David Del Vecchio due to inclement weather condition. The mapping for Quarry Street and Swan Street is complete and the traffic signal design is under review by NJDOT. The George St. plan is moving along and being reviewed by SHPO. The Traffic Calming project plans are also near completion and getting ready to bid in December. The City is contemplating submitting another grant application for the re-pavement of approximately 50 feet on Kline Court.
- 10 Ewing, NJ – The CAI department is received a new application to repave a number of streets within the Township. This application is under review and will be presented to the Commissioners for consideration.
- 11 Trenton, NJ – The final plans are completed and NJDOT indicated that the project is actually under budget as an \$800,000 retaining wall that was to be completed was deleted from the final plans. The agreement between the City of Trenton and the NJ DOT has not been completed due to disagreements on several terms of the contract. A meeting to discuss the status of this project will be scheduled in the near future.
- 12 Delaware Twp., NJ – Application submitted by Township for project on Lower Creek Road did not meet the funding characteristics of the CAI projects
- 13 Hopewell, NJ – A Contract Agreement has been sent to Hopewell for completion.
- 14 West Amwell Twp., NJ – Project 1 (Reconstruction of Lambertville-Rocktown Road, Section 11) preliminary plans were received last week and are under review. Project 2 (Extension of Reconstruction to Lambertville-Rocktown Road, Section 12) has been approved.
- 15 Holland, NJ – The Township has provided the required insurance, the agreement and Appendix B. These are all under review for final execution
- 16 Morrisville, PA – West Bridge St. plans are fine and waiting for Penn DOT HOP approval. Penn DOT requested that parking be restricted to one side of road due to pavement width.
