Response: The length of the contract will be three years.

7. Who are the current Medical and PBM (Pharmacy Benefit Management) vendors?

Response: Our current administrator for Medical is Independence Administrators and for Prescription our administrator is Express Scripts.

8. What are the current Plan designs?

Response: See the Commission's 2017 Benefit Summary attached hereto as Exhibit "A".

9. Who is the Commission's HRA vendor?

Response: The Commission does not currently have or offer an HRA.

10. What are the HRA employer contribution amounts?

Response: The Commission does not currently have or offer an HRA.

11. Are there any wellness programs in place? If yes, describe.

Response: The Commission does not currently have a wellness program in place.

12. Are there any organized labor unions? If yes, how many?

Response: There are no organized labor unions at the Commission.

13. The RFQ address pre-65 retirees. Are there any post-65 retirees?

Response: Yes, the Commission offers post-65 retiree health insurance benefits.

Response: The Commission does not use a vendor for open enrollment.
