ADDENDUM NO. 2

CHANGES TO THE NOTICE TO CONTRACTOR:

1. In the fourth line of the first paragraph on Page 1 change “TUESDAY, November 22, 2016” to “THURSDAY, December 22, 2016”.
2. On Page 7: Replace the following paragraph which had been revised via Addendum No. 1 and which presently reads: “The Commission is contemplating the use of a Project Labor Agreement (PLA) for this Contract. A final decision as to the inclusion of a PLA has not yet been made. However, if the decision is made to utilize a PLA, such notice is expected to be issued on or before October 7, 2016 and the terms, conditions, requirements, and obligation of the Contractor under the PLA will be issued via addendum.” with: “The Commission will be using a Project Labor Agreement (PLA) for this Contract. The terms, conditions, requirements, and obligations of all signatory parties to the PLA, including the Contractor, will be issued via addendum on or before November 10, 2016.”
3. On Page 7: Replace the following paragraph which had been revised via Addendum No. 1 and which presently reads: “The Commission is contemplating the use of an Owner Controlled Insurance Program (OCIP) for this Contract. A final decision as to the inclusion of an OCIP has not yet been made. However, if the decision is made to utilize an OCIP, such notice is expected to be issued on or before October 7, 2016 and the terms, conditions, and requirements of the OCIP will be issued via addendum.” with: “The Commission will be utilizing an Owner Controlled Insurance Program (OCIP) for this Contract. The terms, conditions, and requirements of the OCIP will be issued via addendum on or before November 10, 2016.”

CHANGES TO THE GENERAL PROVISIONS:

1. On Page GP-26 under NOTES TO CONTRACTORS under SECTION 113-INSURANCE AND INDEMNIFICATION REQUIREMENTS first, at the end of Note 2 remove the word “**Insurance:**” and place it as a new header above the next paragraph on that page which begins with “Prior to Commencement” and secondly replace Note 2 in its entirety with the following: “2. The Commission will be utilizing an Owner Controlled Insurance Program (OCIP) for this Contract. The terms, conditions, and requirements of the OCIP will be issued via addendum on or before November 10, 2016.”

CHANGES TO THE PREVAILING WAGE RATES:

- 1 On Page M-1: Replace the first paragraph with the following paragraph “The Commission will be using a Project Labor Agreement (PLA) for this Contract. The terms, conditions, requirements, and obligations of all signatory parties to the PLA, including the Contractor, will be issued via addendum on or before November 10, 2016.”
