Sealed bids for Contract No. T/TS-556A Capital Project 0925A, Bridge Monitoring System – Select Bridges will be received by the Delaware River Joint Toll Bridge Commission at its headquarters in the Administration Building, 110 Wood and Grove Streets, Morrisville, Pennsylvania 19067 until **2:00 PM** (Local Time), Wednesday, August **22**, **2018** at which time and place all bids will be publicly opened and read.

All work in this project, consisting of, but not limited to, the following items of work, shall be carried out according to the Contract Plans and Specifications within the specified construction time limitations. Specific items of work include, but are not limited to:

- A. *Oversized Vehicle Detection System:* Construct/install components of the Oversized Vehicle Detection System, and integrate into existing ESS surveillance system on each approach to the following five (5) bridges:
 - 1. New-Hope Lambertville Toll Supported Bridge
 - 2. Centre Bridge-Stockton Toll Supported Bridge
 - 3. Riegelsville Toll Supported Bridge
 - 4. Northampton Street Toll Supported Bridge

- B. *Structural Health Monitoring System:* Install components of the Structural Health Monitoring System at the following five (6) bridges:
 - 1. New-Hope Lambertville Toll Supported Bridge
 - 2. Centre Bridge-Stockton Toll Supported Bridge
 - 3. Riegelsville Toll Supported Bridge
 - 4. Northampton Street Toll Supported Bridge
 - 5. Riverton-Belvidere Toll Supported Bridge

Each bid must be accompanied by a bid security in the form of a Certified Check or Bid Bond made payable to the Delaware River Joint Toll Bridge Commission in the sum of ten percent (10%) of the Total Bid Amount. If the Bidder is awarded the Contract and the Bidder fails to execute the Contract, furnish the performance and payment bonds or insurance certificates required within 10 calendar days, the Bidder agrees to forfeit to the Commission, as liquidated damages and not as a penalty, the difference, not to exceed the amount of this bid security, between the amount specified

in this bid and such larger amount for which the Commission may in good faith contract with another party to perform the work covered by this bid; otherwise, the bid security will be returned to the Bidder.

Beginning **Thursday**, **July 12**, **2018** the Contract Documents may be examined at the Commission offices in Morrisville, where a USB flash drive containing electronic copies of the contract documents may be obtained with a money order or company check in the amount of \$25.00, which is not refundable.

Bidders are required to be prequalified. The prime contractor and subcontractors must be prequalified by the Pennsylvania Department of Transportation in accordance with Section 102.01 or the New Jersey Department of Transportation in accordance with the latest edition of the New Jersey Department of Transportation Standard Specifications for Road and Bridge Construction, Section 102.01. In order to be considered the prime contractor, he or she must perform the largest percentage of the work and must be prequalified in the items of work he or she will be performing.

The Prime Contractor must be prequalified in an appropriate number of the following applicable PennDOT Work Classifications: A, P, P7, P8, Q, R.

Evidence of all specified prequalification certifications must accompany the bid.
