1. **BACKGROUND:**

The Delaware River Joint Toll Bridge Commission (DRJTBC) is extending an Invitation for Quote("ITQ") for Various Fuels, Tank Wagon Delivery. 4. **DATE AND TIME FOR SUBMISSION OF QUOTES:**

The Oil Price Daily (OPIS) Rack Price for Monday, December 1, 2025, must be supplied along with your quote sheet.

5. **SUBMISSION OF QUOTES:**

- (a) Quotes are requested for the items described on the quote form attached to this RFQ. Suppliers must complete the Quote Form including Supplier Name and Address, Contract Number, Vendor Number, Contact Person, Telephone/Fax Number, E-mail and Web Address and Quote prices. The Quote Form must be signed (in the case of a hardcopy submission) or submitted (in the case of an electronic submission) by an authorized representative of the Supplier or the quote will be rejected.
- (b) It is the responsibility of each Supplier to ensure that the RFQ Issuing Office receives the quote prior to the Date and Time for Submission of Quotes, noted under Section 4. The RFQ Issuing Office will reject unopened, any late quotes.
- (c) The quote shall be rejected if the items offered by the Supplier are not in conformance with the specifications as determined by the RFQ Issuing Office.

6. **RFQ EXPIRATION DATE:**

Suppliers who receive a Purchase Order through this RFQ process will meet the service requirements of the RFQ Issuing Office for the time, period commencing on receipt of Purchase Orders and expiring on Thursday, 12/31/2026. Based on satisfactory service, purchase orders for 2027 and 2028 may be offered.

7. **ESTIMATED QUANTITIES:**

It shall be understood and agreed that any quantities listed in the Contract are estimated only and may be increased or decreased in accordance with the actual requirements of the RFQ Issuing Office and that the RFQ Issuing Office in accepting any quote agrees to purchase only the services in such quantities as represent the actual requirements of the RFQ Issuing Office.

PRICING

Pricing for all deliveries under this contract will be based on a "Margin-Over-Rack" price as specified in the vendor's response (Bid Sheet) at the end of this document. The "Margin-Over-Rack" pricing method is defined as follows: vendor will be paid for deliveries based on the proposed and agreed monetary margin per gallon over a variable wholesale "rack" price. The rack price will be based on the information provided by the Oil Price Information Service (OPIS, for reference, see www.opisnet.com). The "Margin-Over-Rack" price will be fixed for the duration of the contract. The contracted vendor will be required to include, with each invoice submitted, a daily OPIS report documenting the rack price for the date the delivery was made.

8. MODIFICATION OR WITHDRAWAL OF QUOTE:

- (a) Quote Modification or Withdrawal Prior To Date and Time for Submission of Quotes. Quotes may only be modified or withdrawn by written notice received by the RFQ Issuing Office prior to the exact time and date specified for submission of quotes. The written notice shall specifically identify the quote to be modified or withdrawn. Modifications or withdrawals of quotes received after the exact hour and date specified for submission of quotes shall not be considered, except as provided below.
- (b) <u>Quote Withdrawal After Date and Time For Submission Of Quotes.</u> Suppliers are permitted to withdraw erroneous quotes after the Date And Time For Submission Of Quotes only if the following conditions are met:
 - i. The Supplier submits a written request for withdrawal.
 - ii. The Supplier presents credible evidence with the request that the reason for the lower price was a clerical mistake as opposed to a judgment mistake and was actually due to an unintentional arithmetical error or an unintentional omission of a substantial quantity of work, labor, material, or services made directly in the compilation of the price.
 - iii. The request for relief and supporting evidence must be received by the RFQ Issuing Office referenced in Paragraph 3 of this RFQ within three (3) business days after the Date and Time for Submission of Quotes, but before issuance of a purchase order. iv. The RFQ Issuing Office shall not permit a quote withdrawal if the quote withdrawal would result in award to the same Supplier, its partner, or a corporation or business venture owned by or in which the Supplier has a substantial interest.
 - v. If a Supplier is permitted to withdraw its quote, the Supplier cannot supply any material or labor or perform any subcontract or other work agreement for the Selected Supplier, without the written approval of the RFQ Issuing Office.
 - vi. Firm Quotes. Except as provided above, a quote may not be modified, withdrawn, or cancelled by any Awarded Supplier for a period of sixty (60) days after the date and time for submission of quotes.
- (c) Clarification and Additional Information. After the receipt of quotes, the RFQ Issuing Office shall have the right to contact Suppliers for the purpose of seeking:
 - i. Clarification of the quote which confirms the RFQ Issuing Office understanding of statements or information in the quote; or
 - ii. Additional information on the items offered, provided that this RFQ requires the rejection of the quote for failure to include such information.

9. **SPECIFICATIONS**:

Qualified Suppliers will be required to furnish the various liquid fuel types in accordance with the most current Pennsylvania Commercial Item Description (PCID) or latest American Society for Testing and Materials (ASTM) Standard as listed below. The current versions of the PCIDs are provided as attachments to this ITQ.

- ULS Diesel Fuel No.2 PCID No. 1056, entitled "Fuel, Diesel", effective 3/28/13
- Bio Diesel Fuel PCID No. 1107, entitled "Biodiesel Fuel, B100", effective 3/28/13
- Heating Oil No. 2 ASTM D396, Standard Specification for Fuel Oils
- Unleaded Gas ASTM D4814, Standard Specification for Automotive Spark Ignition Engine Fuel.

10. **PURCHASE ORDERS**:

Purchase Orders will be issued annually for each location and will be done so based on the availability of funds. The totals are based on estimated quantities (more or less) for all fuels at that location. Each location listed below will contact you for deliveries against that particular locations issued Purchase Order. They should also provide a PO number for their location. All invoices must include the PO number and delivery location address. The contracted vendor will be required to include, with each invoice submitted, a daily OPIS report documenting the rack price for the date the delivery was made.

11. **DELIVERIES:**

Supplier shall deliver fuel within two (2) days after receipt of agency request for delivery. In an emergency, situation, the Supplier shall deliver fuel within 24 hours after agency notification of delivery or as otherwise agreed to, by the using agency and the Supplier. Deliveries shall be at the tank inlets at each individual facility for each individual fuel type. The maximum quantity for tank wagon delivery is 5,000 gallons per delivery. There is no minimum delivery quantity.

All delivery tickets must include the PO number and delivery location address.
